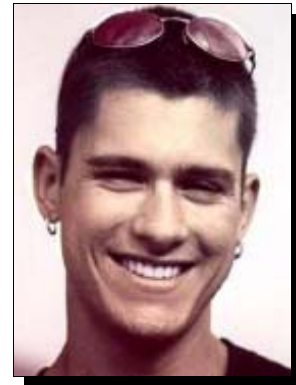

BACKGROUND INFO:

His father was a mechanic and his mother worked in a bakery part time while raising the children. Julian was like most other kids through his schooling, but as he grew older he manifested his skill and love for anything dangerous. Instead of climbing trees like most children he would climb building, and he quickly progressed from small buildings to larger multistory buildings. He would also challenge himself by riding his bicycle down large hills and through the more mountainous regions of the area. Seeing his love for this his parents helped him buy a motocross bike and entered him into local races. He soon made a name for himself on the local circuits, although he wasn't the best racer he was famous for how reckless he was. He started participating in stunt races as well, where he showcased his adrenaline junky style. When he was sixteen he was caught stealing from jewelry stores, he would climb onto nearby buildings and zip line, or repel to the roof of the jewelry stores and would then sneak through the air ducts into the store. It was found that he had burglarized over a dozen stores in the surrounding area. He was sentenced to two years in a juvenile detention center and a heavy fine. He escaped from the detention center but was caught and was returned.
