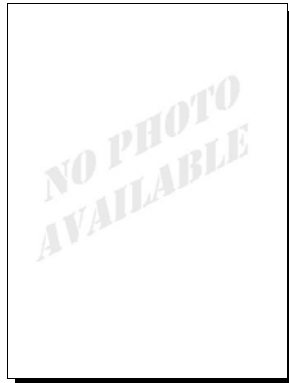

**MISSION BRIEFING:**

The United States Senate Appropriations Committee was founded to assist in allocating legislative funding to various federal programs through the use of assigning appropriation bills to them. Senate appropriation bill S.4721 will be up for renewal and voted on in three days. In summary, appropriation bill S.4721 will greatly increase funding to the IMSTS, or the International Mineralogical Smuggling and Trafficking Sector, which apprehends anyone smuggling exclusive minerals and precious stones into the United States. **MISSION DEBRIEFING:**
